

THE AWAKENING

Assumption of Risk and General Release Form

The undersigned (if he/she has reached the age of 18) or also the Participant's parent or legal guardian, on Participant's behalf (if he/she is under age 18) have chosen to voluntarily participate in The Awakening Missions Trip (hereafter referred to as the "Mission Trip") administratively organized by IPHC World Missions Ministries the Awakening (hereafter referred to as the "WMM") ("Mission Trip" is understood to include all activities at destinations, and all travel to and from such destinations.) This agreement confirms my understanding of the following:

1. Risks of Travel

I understand that participation in the Mission Trip and international travel generally involves risks and conditions to which I am not accustomed. These include without limitation risks involved in traveling to, from, and within the Mission Trip destination; foreign political, legal, medical, social and economic conditions; different standards of design, safety and maintenance of buildings, public places and conveyances; local weather conditions; as well as risks generated by the activities in which I engage while on the Mission Trip. The country or countries to which I will travel may have health and safety standards that differ from those enjoyed in my own country, and I recognize that I may be subjected to potential risks, illnesses, injuries and even death. I have made my own investigation of these risks, understand these risks and assume them knowingly and willingly. I will take every precaution to safeguard my health and to protect my personal belongings from damage or theft. I acknowledge that WMM recommends that I never separate myself from the Mission Trip group, particularly at night. Being alone, especially at night, may present additional danger to my safety and wellbeing. I understand that, although WMM has organized the Mission Trip, it cannot eliminate all risks or guarantee my safety while I am participating in the Trip. I have made the independent judgment to participate in the Trip.

I have read and understood all information present on this application as well as on the U.S. State Department website (<http://travel.state.gov>) about the country or countries to which or in which I am traveling, including, without limitation, the U.S. Department of State Consular Information Sheet and the State Department Warning (if applicable). I also have reviewed the U.S. Centers for Disease Control health advisory information relating to travel abroad found at <http://www.cdc.gov/travel>, and any additional information available from the World Health Organization website (<http://www.who.int/>). With knowledge of this information, I have made the independent judgment to participate in the Trip.

2. Health Insurance, Medical Care, and Safety Concerns

I carry valid and current medical insurance and have a valid insurance identity card to bring. I have determined that this insurance is adequate to cover injuries or illnesses that I may sustain while participating in the Trip. The Awakening WMM will not be held financially responsible for coverage of any costs of medical care I may receive. In the event of an emergency, I authorize WMM trip leaders to seek proper medical care for me when unable to obtain it for myself. The doctor or hospital has my permission to administer medical treatment. I hereby authorize any necessary examination, anesthetic, dental, medical or surgical diagnosis or treatment by any duly licensed physician or dentist and hospital service that may be deemed necessary should I experience any illness or accident. The decision as to what constitutes an emergency or a necessity for medical care may be made in the absolute discretion of any adult representative of WMM. I further agree to hold harmless and indemnify WMM for any and all actions taken by WMM to provide necessary emergency medical care to me during the Mission Trip.

I also understand and agree that if I experience serious health problems, suffer an injury, or am otherwise in a situation that raises significant health and safety concerns, then WMM may contact my parents or any other person whose name I have provided as my "emergency contact." I understand that WMM ordinarily will not initiate such contact without having a discussion with me. Participation on the Mission Trip includes possible exposure to and illness from infectious diseases including but not limited to COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist.

3. Standards of Conduct

I recognize that I assume an important personal obligation to conduct myself in a manner compatible with local laws and regulations; with IPHC WMM's policies for Mission Trip participant's conduct (including without limitation to the mission statement and articles of faith of the IPHC); and with any rules and instructions given by Mission Trip leaders. I promise to act responsibly and will become informed of, and will abide by, all such laws, regulations, policies and standards. I will comply with WMM's policies, standards, regulations and instructions for participant behavior. I understand that I must attend all team meetings required by The Awakening WMM. I agree that WMM has the right to enforce all standards of conduct described above.

4. Funds Raised and Submitted

I am able to provide/raise all required deposits and/or fees necessary to be a part of this Mission Trip. I will to the best of my ability submit all payments on time, with the understanding that I will be provided specific due dates and that all funds must be submitted 2 weeks before the Mission Trip's departure date. Furthermore, I understand that if I withdraw from the mission trip I may in some instances still be responsible for the outstanding balance owed to The Awakening WMM for expenses already secured on my behalf. I am aware that all funds submitted are non-refundable once WMM has processed them.

6. Rights to Images and Captured Content

I give permission to WMM to use any image, activity or performance of the participant (still photography, audio and/or video recording) taken or recorded on the mission trip (whether individually or in a group) for promotional and/or educational purposes. By signing up for, or attending the mission trip, each Individual hereby:

- Acknowledges and agrees that any image taken or recording made of him/her during the mission trip shall be the sole and exclusive property of WMM.
- Consents to the use of his/her name, voice, likeness, interviews, and impromptu casual interactions recorded on video and activities, testimony or other performances and that all may be used WMM for promotional and/or educational purposes as contemplated above, including without limitation the creation, promotion, distribution and sale of any work WMM develops from any still or video images, video and audio recordings and any likeness made of participants present at the mission trip, and that said participant waive any and all rights, throughout the universe that he/she may have arising from the use by The Awakening thereof for promotional or commercial purposes as contemplated and, or described above.

7. General Release

Knowing the risks described above, I agree, on behalf of my family, heirs and personal representative(s), to assume all the risks and responsibilities surrounding my participation in the Mission Trip.

To the maximum extent permitted by law, I release, acquit, and forever discharge WMM and its directors, officers, employees, and agents from all manner of suits, actions, claims, demands, and liabilities, which may arise from my participation in this mission trip, from and against any possible claim, loss or liability for injury to person or property which I may suffer, or for which I may be liable to any other person, related to my participation in the Mission Trip (including periods in transit to or from my destination), resulting from any cause, including but not limited to ordinary or gross negligence.
